<u>Dungeness Crab Test Fishery Results – November 2025</u>

The Washington State Department of Fish and Wildlife (WDFW) has completed the first round test fishery for the Washington coastal Dungeness crab fishery. The test fishery was conducted to assess the condition of the crab resource in advance of the 2025-26 season. Data collected included an assessment of crab shell condition and meat recovery.

Sampling within the Long Beach Test Area was completed on November 3, 2025, and the Westport Test Area was completed on November 11, 2025. The test was conducted in accordance with the Tri-State Coastal Dungeness Crab Revised Pre-Season Testing Protocol, available at the following link: https://wdfw.wa.gov/sites/default/files/2024-10/pre-season-testing-protocols-2024-final.pdf.

Briefly, crab were collected from three stations within the Westport testing area; strings of pots were set at 15, 30, and 45 fathoms at each station. All legal sized male crab caught were included in the meat recovery sample. WDFW staff also collected shell condition data from the same crab collected from all depths and stations. Six crab within each test area were collected for domoic acid testing. The results for all stations and domoic acid results are summarized below.

Definition of shell grades:

- 1A: no flex in body or legs; marketable
- 1B: slight flex in either body or leg; marketable
- II: some flex in both body and leg; not marketable
- III: extreme flex in body and legs; not marketable

WDFW plans to complete the second round of testing within the Long Beach test area by December 7, 2025.

Tri-State policy representatives from the Washington Department of Fish and Wildlife (WDFW), the Oregon Department of Fish and Wildlife (ODFW), and the California Department of Fish and Wildlife (CDFW) are scheduled to meet on November 20, 2025. The Quinault Indian Nation (QIN) has announced their season will open on November 15, 2025. More information about State season openings will be announced next week.
